Certificate from the International Association Sound Massage Therapy for members of the training in the Peter Hess[®] sound massage

This gives our graduates a high-quality, qualified qualification that complies with the code of practice, the ethics and quality guidelines of the liberal health professions. The International Association Sound Massage Therapy e.V. is a member of the umbrella organization of the Free Health Professions (FG). This co-operation also created the curriculum for the new training structure.

Overview of the training structure

• Basic training sound massage (KM I-IV) approx. 3 months practice. In this time you have to give at least 10 sound massages, of which 3 have to be documented in writing. There are also 3 training sound massages, this applies to the countries where it is possible to get them.

- Supervision and final seminar
 - o Graduation: Peter Hess[®] sound massage practitioner / Peter Hess[®] sound massage practitioner (basic degree, PHI certificate, without professional title)
- After that, about half a year practice
- Advanced seminar: "Individual sound massage easy, skilful and safe done!"

• Degree: Peter Hess[®] sound massage practitioner / Peter Hess[®] sound massage practitioner (advanced degree, FV certificate, with professional title). The final certificate is issued by the International Association Sound Massage Therapy, member of the umbrella organization of the Free Health Professions (FG). Only for members of the International Professional Association.

Information for seminar participants:

During the transition from basic education (KM I-IV) to supervision and completion (about 3 months practical experience) 3 training sound massages are to be taken by authorized Peter Hess[®] sound massage practitioners. On the website of the PHI under: <u>https://www.peter-hess-institut.de/</u> you will find a list of the training sound massage practitioners, sorted by postal code. Proof of these 3 sound soundings with evaluation form must be sent to the PHI office in Uenzen no later than 14 days before the start of the final seminar.

For trainees who live **outside of Germany** there is the possibility to receive a training sound massage in the breaks of the sound massage intensively week and one or two more in the time of the supervision weekend.

We also like to give you the contact to other trained sound massage practitioners near you for an exchange.

During that time of basic education (KM I-IV) to supervision, at least 10 sound massages of 60 minutes each have to be given. Three individual sound massages of the above-mentioned 10 sound massages are to be prepared in writing before the supervision (planning sheet and protocol sheet, are given to participants according to KM III-IV by the seminar leader). The three individual sound massages have to be sent 14 days in advance to the respective seminar leader, who leads the final seminar with supervision.
